

MULTIPLE ENTRY VISA CRITERIAS

ELIGIBILITY

Short term General (C-3-1), Ordinary tourist (C-3-9), Business visitor (C-3-4)

VISA TYPE (Visa validity/Duration of stay)

Multiple entry visa (M): 1year/90days; 3years/90days; 5years/90days; 5years/30days

Please note that even if the criteria are met, a visa can be denied if it is deemed possible to illegally stay or commit illegal acts in consideration of past violations, immigration, and residence. Note that the Embassy may request for additional documents if it is deemed necessary for the evaluation of the visa.

Applicants who meet one of the following criteria amongst 'A ~ O'

A. An individual who has visited Korea before

COMMON DOCUMENTS
1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy
3. Documents proving eligibility: (Visited more than 1 time): documents proving financial ability (Base salary in the last 6 months MNT 2.200.000, Tax payment record in the last 6 months MNT 2.200.000 with electronic tax payment certificate) (Visited 4 times in the past 2 years): immigration record (a copy of the page of visa and the date of immigration with signature) (Visited 5 or more times in total): immigration record (a copy of the page of visa and the date of immigration with signature)
4. Marriage certificate (issued within the last 45 days)

B. A public/civil servant or an executive or employee of the state-owned enterprise (manager-level or above)

COMMON DOCUMENTS
1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy
3. Documents proving eligibility: a certificate of employment, a copy of social insurance certificate, or a copy of valid diplomat/official passport (valid for at least 3 months)
4. Marriage certificate (issued within the last 45 days)

C. An executive or employee (manager-level or above) at an airline or a ferry/cruise company providing services to ROK on a regular basis

COMMON DOCUMENTS
1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy
3. Documents proving eligibility: a certificate of employment, a copy of social insurance certificate, or a copy of valid diplomat/official passport (valid for at least 3 months)
4. Marriage certificate (issued within the last 45 days)

D. A holder of an internationally accepted credit card with a limit over \$10,000, having used it over \$2,000 (excluding cash advance) on average for the last three months

COMMON DOCUMENTS	
1.	Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2.	Passport in original and copy
3.	Documents proving eligibility: A bank confirmation (with the credit limit stated), a transaction statement, a photocopy of the credit card
4.	Marriage certificate (issued within the last 45 days)

E. An individual who plans to establish a company working with ROK to engage in the activities such as counseling or signing a contract for development and sales of resource/energy, invited by a domestic public/private organization

2.	Passport in original and copy
3.	Documents proving eligibility: <ul style="list-style-type: none">• Documents proving the company is in the resource/energy business (a Business Registration Certificate, a patent of development, etc.)• A contract of development and sales of resource/energy signed with a company in Korea• A certificate of employment, a copy of social insurance certificate, a payment confirmation of social insurance fee, etc.
4.	Marriage certificate (issued within the last 45 days)

F. Parents or a child of an individual who has acquired Korean nationality, Spouse of Korean national residing in Mongolia or Parents or minor child (under 19 years old) of a spouse of Korean national whose marriage is registered in both countries and married for at least one year

2.	Passport in original and copy
3.	Documents proving eligibility: <ul style="list-style-type: none">• Parents or a child of an individual who has acquired Korean nationality: certificate of alien registration (issued by the immigration office) or a Basic Certificate (detailed)• Spouse of Korean national residing in Mongolia: a copy of passport and a copy of the residence card• Parents or minor child (under 19 years old) of a spouse of Korean national whose marriage is registered in both countries and married for at least one year: marriage certificate from both countries of Korea and Mongolia (Korea: issued within the last 3 months, Mongolia: issued within the last 45 days)
4.	Family relation certificate (issued within the last 45 days)

G. A professional such as a doctor, lawyer or professor, etc., who meets the qualifications that the mission recognizes

4. Marriage certificate (issued within the last 45 days)	

H. A journalist, producer or an editor who is employed for at least one year at a media company recognized by the mission

3. Documents proving eligibility: <ul style="list-style-type: none">• A certificate of employment, a copy of social insurance certificate, a payment confirmation of social insurance fee, a copy of employee badge (reporter, producer, editor, etc.)• An official document of the Association of Journalists, a copy of the membership card of the Association of Journalists• A tax payment certificate of the employer (media company)

4. Marriage certificate (issued within the last 45 days)	

I. An employee who worked as a manager or above for at least one year at a company with annual tax payment record over 500 million MNT or a top 100 tax paying company

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy
3. Documents proving eligibility: an electronic certificate of corporate tax payment (between 01.01 and 12.31 in previous year), a copy of Business Registration Certificate, a certificate of employment, a copy of social insurance certificate, a payment confirmation of social insurance fee
4. Marriage certificate (issued within the last 45 days)

*** Refer to the list of Top 100 Companies with Outperforming Record of Tax Payment (Based on the list of the Mongolian Chamber of Commerce and Industry)**

J. An individual who has a bachelor's degree (excluding associate degree) or above from a four-year university in Korea or an individual who has a master's degree or above from overseas

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy
3. Documents proving eligibility: a copy of degree, a certificate of transcript, a copy of visa of the country where the applicant studied, a copy of the immigration stamps or a confirmation of immigration
4. Marriage certificate (issued within the last 45 days)

K. An individual who is recognized by the mission, whose monthly average salary on the social insurance is at least double of the average monthly wage of urban worker (1.25 million MNT as of 01.2020) for the last six months

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy
3. Documents proving eligibility: a certificate of employment, a copy of social insurance certificate, a payment confirmation of social insurance fee (with payment record for one year from the date of application)
4. Marriage certificate (issued within the last 45 days)

L. An individual who is recognized by the Mission amongst well-known artist, entertainer or athlete (merits in the relevant area, etc.)

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months
2. Passport in original and copy

3. Documents proving eligibility:

- A copy of medals, a copy of the confirmation of award certificate,
- A certificate of employment, a copy of social insurance certificate, a payment confirmation of social insurance fee (if applicable)

The qualifications that the Mission recognizes

- **Entertainment / Arts:** Individuals who have received national medals (labor heroes, state laureate, national actors, merit actors, art contributors)
- **Sports Field:** National Medal winners (Labor Heroes, Merit Athletes, Merit Coaches), Medal winners of the Olympic and Paralympic Games, Medal winners of the World Championships, Medal winners of Asian Games, Medal winners of various World Youth Championships Merit

4. Marriage certificate (issued within the last 45 days)

M. An owner of personal assets (at least 500 million MNT), such as real estate or financial assets (cash)

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months

2. Passport in original and copy

3. Documents proving eligibility:

- a certified copy of real estate register (issued within the last 45 days), a state-certified confirmation of property evaluation (issued within the last 6 months)
- cash reserves for the last 6 months: an average balance statement

4. Marriage certificate (issued within the last 45 days)

N. A spouse or minor child (under 19 years old) of a holder of multi entry visa who meets the requirements amongst 'A~M'

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months

2. Passport in original and copy

3. Documents proving eligibility:

- A certificate of family relations with the holder of Multi entry visa (issued within the last 45 days);
- A Birth registration certificate of a child born with Multi entry visa holders (issued within the last 45 days);
- A copy of the personal information page and visa on the passport of the holder of Multi entry visa

O. An individual (frequent visitor) who has visited Korea at least 4 times within the last 2 years or 10 times in total with at least one entry in the past two years

- Visa validity / Duration of stay : 5 years multiple entry visa /30days

COMMON DOCUMENTS

1. Visa application form (Form 17), one 3.5x4.5cm photo in color, taken within the last six months

2. Passport in original and copy

3. Documents proving eligibility: immigration record (a copy of the page of visa and the date of immigration with signature)

The record must include an entry in the past 2 years.
